The Government Tenders Department (GTD, Procuring Entity) invites Jordanian and International Contractors eligible to European Investment Bank (EIB), that satisfy the prequalification criteria set below in this invitation and in the Prequalification Documents, to submit their applications for Performance-Based Operation and Maintenance Contract for Wadi Arab II Water Supply System (“the Project”).

Prequalification is open to local and foreign contractors as follows:

- A. Jordanian Contractors classified by (GTD) and hold a valid classification certificate in the field of Water and Sewerage, specialized in Wastewater and Drinking Water Treatment Plants as First Grade, single or in the form of Joint Venture (JV);
- B. International Contractors;
- C. Jordanian Contractors and International Contractors in the form of (JV).
 - Any Jordanian Contractor in the JV must meet the requirements as listed in (A) above.
 - The JV shall be limited to (2) members.

1. Project Description

The Ministry of Water and Irrigation/ Water Authority of Jordan (WAJ) (hereinafter called “Employer” or “Promoter”), with the financing support from the European Investment Bank (EIB), hereinafter referred to “the Funding Agencies”, is intent on using part of this fund to cover for a portion or all of the O&M cost of the Wadi Arab II Water Supply System. The Employer intends to prequalify firms for the O&M services of the Wadi Arab II Water Supply System. The contract is expected to be implemented for a 5-year O&M services period and with the optional extension for additional 5 years, subject to Employer approval.

2. Scope of Work

The Project scope is the operation and maintenance (O&M) of the existing Wadi Arab II Water Supply System located in Irbid Governorate. The project consists of the intake system, the Wadi Arab II Water Treatment Plant (WTP), the four pump stations (PS0, PS1, PS2, and PS3) and associated 1,200-millimeter (mm)-diameter transmission pipeline to convey and deliver the treated water to the inlet of the Zabda Reservoir in Irbid City. The WTP, located in the Jordan Valley at Manshyeh, is a surface WTP with a total capacity of 30 million cubic meters per year (MCM/year) and designed to be expanded to 45 MCM/year. The WTP processes consist of intake screens, intake pump station, pre-sedimentation basin, rapid mix flocculation basin, sedimentation basin, dual media filters, granular activated carbon (GAC) adsorbers, ultraviolet (UV) disinfection followed by chlorine disinfection in a clearwell. The sludge is further treated by gravity thickeners followed by centrifuge for dewatering or disposal in drying beds.
